- 2. All requirements must be met and all information must be completed in order for the application to be considered.
- 3. Enclose with your application three sealed letters of reference from a teacher or other adult who is familiar with your achievements and abilities. Instruct your reference to sign his/her name across the seal of the envelope. Applications without sealed letters of reference will not be considered; do not send letters of reference separately.
- 4. Enclose a certified and sealed college or university transcript. Applications without certified/sealed transcripts will not be considered.
- 5. Retain a copy of the completed application for your files.
- 6. Applications must be signed in order to be considered.
- 7. All application documents must be received prior to the application deadline to be considered.

By-Laws of the Pipeliners Club of Oklahoma City

SCHOLARSHIP POLICY: Summary of Requirements

Section 3.1 To receive a scholarship, an applicant must attend a qualified educational institution. Scholarship award eligibility shall be limited to Pipeliners Club of Oklahoma City's members and relatives of member's in good standing. (A member in good standing for scholarship purposes shall have paid dues for a minimum of two (2) concurrent years, one being the year of application. In addition, the sponsoring member must have attended a minimum of four (4) meetings and/or events in the previous calendar year, evidenced by attendance records prior to the filing of the scholarship application.

Scholarships will only be awarded to students attending an educational institution listed on the Department of Education's Accreditation database and where scholarship award will only be used for qualified education expenses.

Section 4 Scholarship funds will be sent directly to the qualified educational institution to be placed in the scholarship recipient's bursar account to be managed by the qualified educational institution to ensure funds are only spent for qualified educational expenses only.
